

**All participants must FULLY complete & sign the following indemnity before being permitted on the track. Please tick all boxes and complete declaration on the reverse of the form.**

THE CONSUMPTION OF ALCOHOL OR DRUGS IS STRICTLY FORBIDDEN. ANY PERSON *WHO APPEARS* TO BE UNDER THE INFLUENCE WILL NOT BE ALLOWED TO PARTICIPATE.

**GENERAL**

- I understand that motorsport is hazardous, and I am voluntarily exposing myself to risk of damage or loss or personal injury by participating in a track event. I understand that the purpose of the event is to allow the participants to improve their skills and learn the handling characteristics of the motor vehicle they are using. I am aware that other track users will have varying levels of competence and my own driving must take this into account.
- I understand that any insurance carried by Duke Track Days Ltd. and/or the event location operator in respect of any liability which might arise out of the track event will be limited, and that my motor vehicle third party and public liability insurance (if any) is unlikely to cover me for my losses, liabilities or personal injury.
- There is no scrutineering. All participants must ensure their motor vehicle is fit for the purpose. Duke Trackdays will refuse entry to vehicles that appear to be in an unsatisfactory condition. Should your motor vehicle fail and cause an accident then I understand I may be held liable for that accident. Vehicles may be excluded from further participation following any incident.
- No timing devices are allowed. This includes timing beams and transponders
- I am responsible for the way in which I use the track, and for wearing appropriate protective clothing. Arms and legs must be covered and a helmet must be worn at all times. Seat belts must be secured.
- Marshals will observe me on track and if I, or my motor vehicle, infringe any relevant rules or regulations or appear dangerous I may be excluded and lose track time. I understand that the payment(s) I have made to Duke Track Days Ltd. will not be refundable under these circumstances.
- All track discipline is under the auspices of the Clerk of the Course whose judgement is final.
- Towing Eye must be fitted and all loose items are adequately secured outside of passenger compartment

**TRACK DISCIPLINE**

- Overtaking is only allowed on the LEFT HAND SIDE. No overtaking is allowed in braking areas or through corners
- I will obey the flag signals as listed below
- |           |  |
|-----------|--|
| YELLOW    | Caution, slow down, be prepared to stop, no overtaking   |
| RED       | Slow down and return immediately to the pits (Be aware slow moving emergency vehicles which may be on circuit) |
| GREEN     | Circuit clear  |
| BLUE      | A faster vehicle is approaching and may wish to overtake   |
| BLACK     | Return to pits immediately   |
| CHEQUERED | End of session   |
- Do not stop on circuit unless in an emergency. Should mechanical failure occur, then pull off and await marshal intervention. Do not get out of vehicle unless absolutely necessary
- No hand held cameras or telephones to be used whilst on circuit

**DECLARATION**

**I declare: -**

- That I am fit and healthy and that my eyesight (with lenses if worn) is adequate for track use and that I am physically capable of controlling my motor vehicle on the track whilst testing its performance on the track.
- That any motor vehicle for which I am responsible, and that I will use on the track, is in good and suitable mechanical condition.
- That I hold a current full driving licence.
- That I will not participate in a track event whilst under the influence of alcohol or intoxicating drugs.
- I agree to make no claim against Duke Track Days Ltd. or its officers or agents in respect of any loss, damage or injury suffered or caused by me during a track event, and to indemnify them against their costs and losses arising out of any claim made against them by anyone to the extent that such costs and losses are attributable directly or indirectly to my participation in a track day.
- I have read and agree with the above declaration and indemnity, and agree that its terms will also apply to my participation in any future track day organised by Duke Track Days Ltd., unless I sign a subsequent declaration and indemnity, which will then take precedence.
