



KARTING DECLARATION AND INDEMNITY

All participants must FULLY complete & sign the following indemnity before being permitted on the track

I wish to drive a Kart in a track event organised by Duke Track Days Ltd.

I understand that motorsport is hazardous, and I am voluntarily exposing myself to risk of damage or loss or personal injury by participating in Karting. I am aware that other track users will have varying levels of competence and my own driving should therefore take this into account.

I understand that any insurance carried by Duke Track Days Ltd. and/or the event location operator in respect of any liability which might arise out of the Karting event will be limited and that, whether I am using my own Kart or that belonging to another, third party and public liability insurance (if any) is unlikely to cover me for my losses, liabilities or personal injury.

I also understand the following: -

1. I am responsible for the way in which I use the track, and for wearing appropriate protective clothing.
2. Marshals will observe me on track and if I infringe any relevant rules or regulations or appear dangerous I may be excluded and lose track time. *I understand that the payment(s) I have made to Duke Track Days Ltd. will not be refundable under these circumstances.*
3. All track discipline is under the auspices of the Track Director whose judgement is final.

I declare: -

1. That I am fit and healthy and that my eyesight (with lenses if to be worn) is adequate for Karting and that I am physically capable of controlling the kart whilst testing its performance on the track.
2. That I will not participate in a karting event whilst under the influence of alcohol or intoxicating drugs.
3. That I shall only be allowed access to the track after attending a briefing session.
4. That I shall at all times comply with the Rules and Regulations of Duke Track Days Ltd.

I agree to make no claim against Duke Track Days Ltd. or its officers or agents in respect of any loss, damage or injury suffered or caused by me during a Karting event, and to indemnify them against their costs and losses arising out of any claim made against them by anyone to the extent that such costs and losses are attributable directly or indirectly to my participation in Karting.

I have read and agree with the above declaration and indemnity, and agree that its terms will also apply to my participation in any future Karting event organised by Duke Track Days Ltd., unless I sign a subsequent declaration and indemnity, which will then take precedence.
